## DESCRIPTION

This plot of Everett's First Addition to the Town of Concrete embraces that portion of the west 1/2 of Sec. 11 Twp. 35 N., Range 8 E. W.M., more particularly described as follows: Beginning at the Centre of Sec. 11 Twp. 35 N., Range 8 E. W.M., thence S 27° 00' E. along the north and South Centre line of Sec. 11, a distance of 273.69 ft. thence N 50° 50' 00" W. along the east boundary line of the Great Northern R.R. Right of Way, a distance of 1265.64 ft. thence N 8° 52' 00" E. a distance of 62.15 ft. thence S 61° 26' 00" E. a distance of 1089.61 ft. thence S 27° 00' E. a distance of 65.21 ft. to the point of beginning.

The initial point of this plot is the centre of Sec. 11, Twp. 35 N., Range 8 E. W.M. The sizes of lots, streets and alleys are as shown on the annexed plot in feet and decimals.

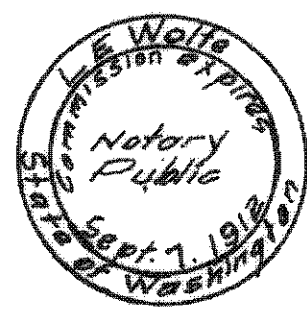
