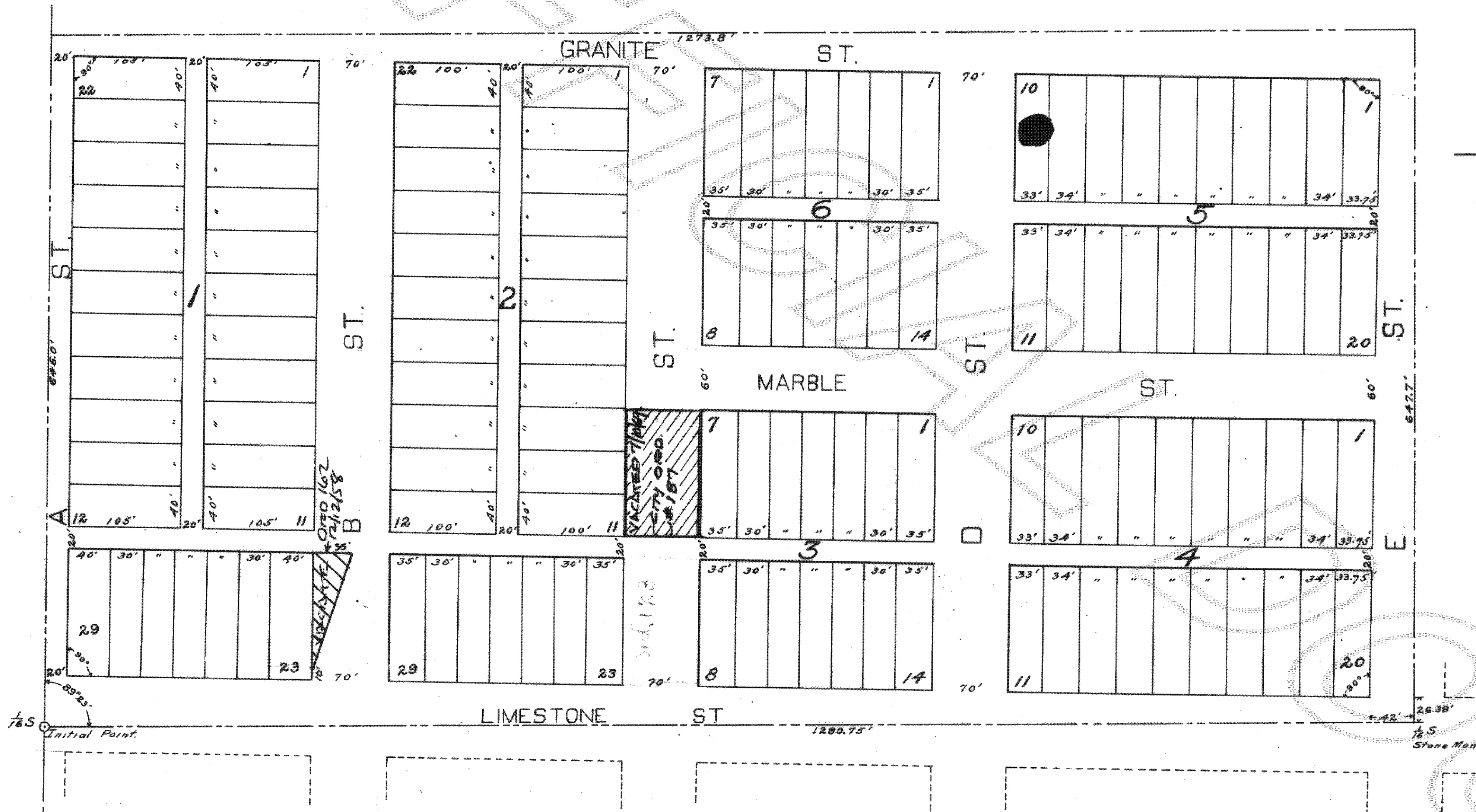


MARENGO ADDITION TO BAKER.

This is to certify that on the 24th day of June A.D. Nineteen Hundred Ten, the following resolution, to wit:

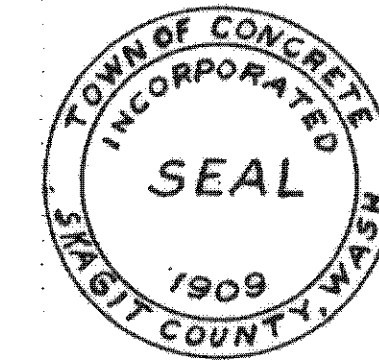

DESCRIPTION

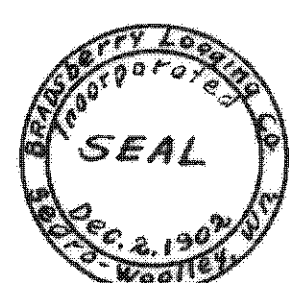

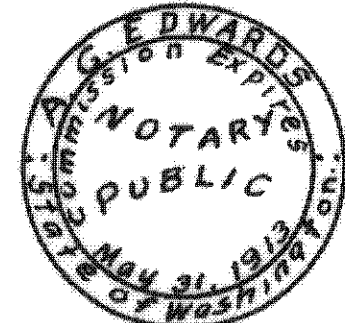
