

# MILLER ADDITION TO BAKER

SKAGIT COUNTY, WASH.

### DESCRIPTION

Miller Addition to Baker covers the S.W. 1/4 of these 1/4 of the N.E. 1/4 and the N. 1/2 of the S.W. 1/4 of the N.E. 1/4 minus a strip 125 ft. wide extending from the R.R.R. of way, north along the west boundary to the County Road now Main St. and minus that portion of the County Road embraced in Central Addition to Baker, and minus the R.R.R. of way as shown on the plat. All in section 10, Twp 35N, R. 8E, W. 1M, Skagit Co. Wash.

All dimensions are as shown in feet. The initial point is an iron pipe at the S.E. corner of the S.W. 1/4 of the S.E. 1/4 of the N.E. 1/4, said Sec. 10, A.S. Meier & Co.

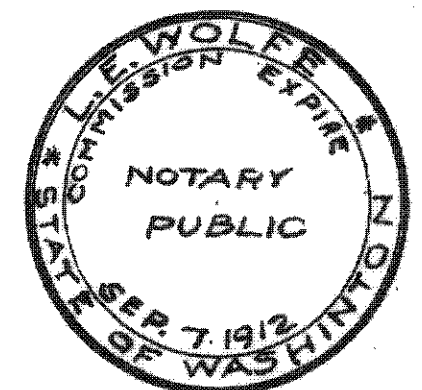
