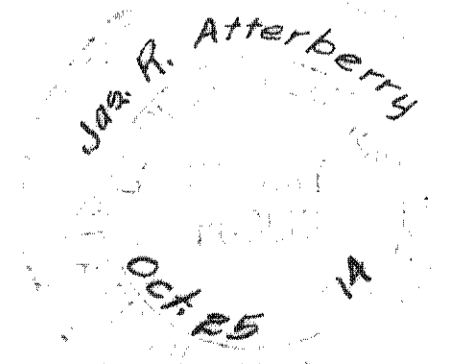

Beginning at the South west corner of lot 1 block 1 of Shea's Home Addition to Lyman, thence north 65 feet to its north west corner thence west 2 feet; thence North along the East line of Lyman avenue 449.5 feet to the south line of the north half of the north west quarter of the north west quarter of said section 17, thence N89°42'E 420 feet along the south line of said north half, thence South 450.69 feet, thence west 169 feet, thence South 180 feet to County road, thence West 40 feet thence north 100 feet, thence West 9 feet thence North 14 feet, thence West 200 feet to place of beginning
